



Dear Scholarship Applicant:

Following is the application for a C.A.H.P. Credit Union Educational Scholarship. Your completed scholarship application must be postmarked by May 12, 2012. The Scholarship Committee will not accept applications postmarked after that date. Incomplete or late applications **will not** be returned to the sender.

Applications must contain **official** transcripts to qualify for review by the C.A.H.P. Credit Union Scholarship Committee. It is the sole responsibility of the applicant to ensure that all applicable transcripts are made available.

Applicants must meet the following eligibility requirements:

- Applicant must be a Credit Union **primary** member at the time of application.
- Applicant must be a U.S. citizen.
- Applicant must be accepted to, or enrolled in, an accredited **four-year** college or university.
- Applicant must have at least a 3.0 grade point average for all college credits earned (entering freshmen must have a High School grade-point-average of at least 3.0).
- Applicant must have **no** felony convictions.
- Applicant must furnish **official** transcripts and test scores (see below) to the C.A.H.P. Credit Union Scholarship Review Committee.

To meet the eligibility requirements, please print out and complete the following application and attach the following:

- A Personal Statement outlining your academic goals and objectives.
 - Include your reasons for attending college and other information you feel is pertinent to your application, such as volunteer work and extracurricular activities. Use the space provided on the application for your statement. Use additional sheets if necessary.
 - Please list anticipated tuition and percentage of funding resources.
- Proof of acceptance, or enrollment, as a full-time student at an accredited four-year college or university is required.
- Entering freshman please send a copy of your SAT or ACT score(s).

THE APPLICATION MAY BE HANDWRITTEN, BUT **THE PERSONAL STATEMENT MUST** BE TYPED OR COMPUTER PRINTED. *ANY PERSONAL STATEMENT THAT IS HANDWRITTEN WILL BE DISQUALIFIED.*

The Scholarship Committee will meet in July to select the six individual winners. Winning applicants will be notified by mail with a letter of confirmation shortly after the Scholarship Committee makes their decision. The Scholarship funds will be deposited directly to the winners' account.

All decisions of the C.A.H.P. Credit Union Scholarship Committee will be final.
